Sajal Kumar Mahanta, OE 3. — entered the premises of Sri Bhakti Bhusan Kumar, S/O- Amulya Ratan Kumar of villege Biddri, P.O- Tunturi PS- Bagmundi, Dist- Purulia and found Sri Bhakti Bhusan Kumar was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.2 KVA. As Sri Bhakti Bhusan Kumar S/O- Sri Amulya Ratan Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1.
