Choudhury, DE & Station Manager of Balarampur CCC, WBSEDCL do hereby lodge complaint against ~~Bibek~~ Bibek Kumar S/o Shikhar Kumar resides at vill- Tentlow, P.O- Tentlow, P.S- Balarampur Dist- Purulia. to the effect that received an information that the aforesaid accused person is committing theft of electricity in his residence by way of hooking from the nearby LTCH line of WBSEDCL to bypass the proper registration of units in the energy meter of WBSEDCL.

Acting upon such information today on 20.9.2018 from 3.10 pm to 3.40 pm. I along with Sri Matheon Saha, Manager (F&A), Sri Ambujakshya Pratihar, S.O, Sri Ashutosh Sharma, SAE(E) of Purulia Region and other officials of WBSEDCL Purulia Region & Sri Manab Kr. Maji SAE(E) Balarampur CCC WBSEDCL and the technical persons of M/s. Ajoy Kr. Ghosh (enlisted agency of WBSEDCL) inspected the premises of Bibek Kumar and held said.

During said inspection it was detected that accused Bibek Kumar is using electricity dishonestly by way of hooking from the nearby LTCH line of WBSEDCL to bypass the proper registration of units in the energy meter of WBSEDCL & the energy is being stolen. From this hooking arrangement he is using 2 Nos 100 Watts

Lamp & 120 Ceiling Fan having connected load 0.26 kW. The Service Connection bearing consumer ID 202049296 stands recorded in the name of the accused.

I prepared inspection report in presence of the accused and assessed the load as 0.26 kW. Details have been mentioned in the inspection report but the accused refused to sign on it.

I directed Sri Rajib Sahis, Supervisor of M/s. Ajoy King Shokh (enlisted agency of WBSEDCL) to disconnect the hooking arrangement of the aforesaid accused accordingly Sri Sahis disconnected the said hooking arrangement.

I prepared seizure list in presence of the witnesses, details of seizure have been mentioned in the seizure list and signature of the accused could not be obtained as he refused to sign on it. The local people gathered there witnessed the incident but refused to sign on the seizure list and inspection report.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence u/s 135(i)(a) & 135(i)(c) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
