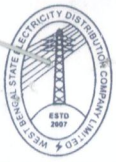

Hembram, S/O Lt. Ludhu Hembram, resides at vill - Kerowa, Mondal Basa,
P.O - Ghatbera, P.S - Balarampur, Dist - Burdha to the effect that received
an information that the aforesaid accused person is committing theft
of electricity in his residence by way of hooking from the nearby LTOH line
of WBSEDCL to bypass the proper registration of units in the energy meter
of WBSEDCL.

Acting upon such information ~~by me~~ yesterday on 14.9.2018 from 8:30 PM
to 9:10 PM I along with Sri Manab Kr. Maji, SAE Balarampur CCC, Sri Subhasis
Mahato, OE Balarampur CCC and the technical persons of M/s Ajoy Kr. Shosh
(enlisted agency of WBSEDCL) and other officials of Balarampur CCC
inspected the premises of Lachhu Hembram and held raid.

During raid and inspection it was detected that accused Lachhu Hembram
is using electricity dishonestly by way of hooking from the nearby LTOH line of
WBSEDCL to bypass the proper registration of units in the energy meter of WBSEDCL
& the energy meter is found in dismantled condition which was done by the

accessed himself. From this hooking arrangement he is using 2 Nos 100 Watts Lamp & 1 No Ceiling Fan having connected load of 0.26 kW. The service connection bearing consumer ID 242277109 stands recorded in the name of the Accused has been disconnected on spot upon detection of theft of electricity.

I prepared inspection report in presence of the Accused and assessed the load as 0.26 kW. Details have been mentioned in the inspection report and duly signed by the accused.

I directed Sri Rajib Saha, Supervisor of M/s Ajoy Kr Ghosh (enlisted agency of WBSEDCL) to disconnect the service connection of the above said consumer ID accordingly Sri Saha disconnected the said service connection.

I prepared Seizure List in presence of the witnesses, details of seizure have been mentioned in the seizure list and obtained the signature of the accused. A copy of the seizure list was handed over to the accused. The local people gathered their witness the incident but refused to sign on the seizure list and inspection report.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence u/s 135(i)(a) & 135(i)(c) of Electricity Act 2003 (Amended in 2007)

Kindly treat this complaint as FIR and take necessary action against the accused.
