

I, Tapas Dutta, S.I, OC Bandwan PS, Purulia, do hereby submit complaint against 90/100 unknown supporters of "BHARAT JAKAT MAJHI PARGANA MAHAL", to the effect that on receipt of information of road blockade Dated, 24/9/18 at about 06:25 hrs vide Bandwan PS GDE No- 1234, Dtd-24/9/18 myself along with forces left PS for Kuilapal mor under Bandwan PS Vide Spl. CC No 41/18, Dated, 24/9/18 at 06:25 hrs (.) After reaching there at about 07:05 hrs, I found that the Road at Kuilapal mor which runs between Bandwan & Jhilimili (SH -5), has been blocked by above noted persons with Bow, arrow, lathi, and banner / flags under the leadership of unknown accused (.) They blocked the State Highway on the issue of different demands relating to initiation of Olchiki script in Santali language reservation in different job etc. and thus caused harassment to innocent people i.e Bus passenger, Drivers, riders etc. (.) The accused persons were raising slogans in Bengali like "EHONI AMADER DABI MANTE HOBE, NA HOLEY ROAD BLOCKADE CHOLCHEY CHOLBEY, etc" against Administration using microphone / Mike without any permission (.) I have tried to pursue the agitator to withdraw the blockade and help police to disperse the mob (.) It is also found more than 30/35 vehicles loaded with passengers and drivers including patients etc from Jhilimili side and Bandwan side were detained there and subjected to enormous sufferings (.) After a long discussion, they withdrew the blockade at about 21:45 hrs (.) During persuasion, few of agitators became angered & pushed down one personnel namely C/241 Sumit Chakraborty who sustained injury on his person. However, I have somehow managed the situation and continued discussion. It continued from 06:25 hrs to 21:45 hrs. Few photographs have been taken and Videograph made on the above incident of road blocked (.) After returning to P.S, I Start Suo-muto Bandwan PS case No- 77/18 Dtd- 25/09/18 U/S- 143/283/186/353 IPC and read with Sec. 18 of the West Bengal Highway Act 1964 & 32 Police Act. against the unknown accused persons as above.
