I do hereby lodge complaint empowered by enabling Te Electricity Act - 2003, subsequently Electricity (Amendment) Act 2007 to the effect that Dubraj Hansda, S/O - Lt. Rameswar Hansda resides at Simisgora was enjoying electricity unauthorised by i.e. by means of direct hooking from the nearest L.T.O.H line and causing revenue loss of WBSE DCL i.e. Dubraj Hansda, S/O - Lt. Rameswar Hansda of Simisgora, P.S - Bundwan, Purulia has committed theft of electricity U/S 135(1)(a) of The Electricity Act 2007.

On 12/09/2018 about 14-15 hrs Ramesh Singh, SM, Bundwan CCC, WBSEDCL.

Entered the premises of Dubraj Hansda, S/O - Lt. Rameswar Hansda and inspect his/her premises. During inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal hooking from the nearest L.T.O.H line of WBSEDCL, a.i. u/s 135 (1)(a) was detected.

From the above arrangement he/she was using the following electrical equipments:

- 1) Fan - 3 Nos.
- 2) Lamp - 1 No.
- 3) Bulb - 2 Nos.

Out of which I seized the following:

- 1) 2 Core PVC wire with hooking device.
- 2) Switch Board with switch and socket.
- 3) Electrical Bulb 1 No.

Seizure list was prepared at the site and accused person refused to sign/seal.

The inspection team left the premises at 14-15 hrs on 12/09/2018.

The accused person has committed an offence U/S 135(1)(a) of The Electricity Act - 2003 & subsequently Electricity (Amendment) Act - 2007.

You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
