

I, Tapas Dutta, S.I, OC Bandwan PS, Purulia, returned to P.S along with force I, in producing herewith the seized materials do submit Suo-muto complaint against 400/500 unknown persons including male, female & children of Ashpara, Sirishgora & Mangla villages to the effect that over the alleged incidents of attempt to rape to one Adibasi girls by Non-Adibasi persons, the above accused assembled from 19:00 hrs on 27/9/18 near Ujjwala medical hall, where the alleged incident of attempt to rape was committed by the owner / staff of the medical hall. They (The above accused) started agitating against the alleged act of attempt to rape upon her there without paying heed of follow up action from the end of police. Then I requested senior officer to send more force immediately. Gradually the mob became furious & attacked the said medical stall suddenly where many medicine were in stock. Sri Sanjay Halder, the brother of the alleged person was also there. The mob comprising male & female with lathi, came down upon said Sanjay Halder as well as another, Uma Shankar Mahato. Police available there could manage to save them from the attack & they left the place. In the mean time, the unlawful mob broken the tube light, ransacked the medicine stall, damaged many medicines, files, furniture's, threw out many of those & put fire on those outside of the Ujjwala Medicine hall. Later police could disperse them from the medicine stall though, yet the mob gathered on the main road (high way, S.H-V) & therefore road blockade has been called. Since the mob comprised females & Children, we preferred persuasion to pacify the mob. Ultimately the mob dispersed at about 03:15 hrs. There I seized (1) Burnt & damaged Almirah (2) Burnt parts of Table Fan (3) Burnt part of revolving chair (4) Few Burnt Medicines. (5) Few Burnt papers. **After returning to P.S, I Start Suo-muto Bandwan PS case No- 79/18 Dtd- 28/09/18 U/S- 147/148/149/448/323/427/435/186/283 IPC and read with Sec. 18 of the West Bengal Highway Act 1964 against the unknown accused persons as above.**
