Shyam Mahato of Vill- Kudlung and 150/200 unknown BJP supporters to the effect that today on 26-09-18 I along with C/430 Sachit Singha and C/346 Shaktipada Rajak was performing mobile duty at P.S area in c/w 12 hours 'Bangla Bundh'. At about 11-30 hrs received an information over mobile phone from the on duty Village Police Uttam Kumar Mahato that about 200 BJP supporters obstructed Barabazar Manbazar road (SH-4) at Sindri Bazar for which one Boro bound SBSTC bus bearing registration number WB-39A-2770 and some good vehicles have been detained there. After having the information I moved towards Sindri and also informed my superiors. Arriving at Sindri at about 12-15 hrs I noticed that approximately 200 BJP supporters blocked Barabazar Manbazar road by placing two guard rails on road and setting BJP flag in those guard rails. We requested them to remove the guard rails and clear the road for smooth passage of vehicles and passersby. But they did not respond to our word rather started abusing and accelerated their activities. I declare the gathering and assembly unlawful and asked to disperse immediately. Then the mob became violent and attacked Police with lathi, tangi, forsha (axe), wooden bar, bows and arrows. The accused persons also started pelting stones aiming to Police resulting injury to myself and serious injury to C/430 Sachit Singha and C/346 Shaktipada Rajak. With the help of reinforcement from Sub-division HQ and District HQ, above persons could be apprehended and others flee away. The persons stated their name and address as mentioned above and also stated some of their associates. I arrested the accused persons and took into custody. I along with C/430 Sachit Singha and C/346 Shaktipada Rajak had been to Barabazar BPHC and undergone treatment there.

The accused persons cause hindrance to the vehicles and passersby in a busy State High Way for a long period and also voluntarily cause grievous hurt to on duty Police personnel to deter them from discharging their duty.

Under the above circumstances, I therefore pray that a case may kindly be started against the above named 30 accused persons and 150/200 unknown supporters of BJP under appropriate section of law for their act of offence.
