PURULIA was involving electricity unauthorizedly by direct tapping from insured J. O. line through 1 Core PVC cable and he has committed theft of electricity UD 176214 of the electricity Amendment Act 2007.

Entered into the premises of M/s. Singh Sarda S/O Harihar Singh Sarda Of P.S. Barabazar, P.S. BARABAZAR, DIST. PURULIA and inspected the premises at 12.25 P.M.

During inspection, I was found that M/s. Singh Sarda S/O Harihar Singh Sarda Of P.S. Barabazar, P.S. BARABAZAR, DIST. PURULIA was involving electricity illegally by direct tapping from insured J. O. line through 1 Core PVC cable in the premises at Barabazar with connected load of 2.17 KW.

Along the above arrangement he was using the following equipment

1. 2 No Electric Bulb 60 watt

Out of which used the following articles

1. 1 No of 1 core PVC Cable 3 nos. Approx with tapping device
2. 1 No Electric Bulb 60 watt

Seizure list was prepared at site and accused person refused to sign after process of inspection and seizure list was left the premises at about 12.40 P.M.

The said person has committed an offence UD 176214 of electricity act 2007 subsequently electricity Amendment Act 2007.
