Sir,

I SI Sasthi Pada Jhariat of Barabazar P.S do hereby lodge complaint against 30/35 unknown supporters of 'Bharat Jakat Majhi Pargana Mahal' to the effect that today on 24-09-18 in course of patrolling duty at P.S area had been to Hullung more near Fagudih football ground under Barabazar P.S by availing govt. vehicle having Registration No- WB- 26K- 5475 with accompanied C/- 1228 Bablulal Hansda, C/- 942 Dipak Mukherjee and found that about 30/35 unknown supporters of 'Bharat Jakat Majhi Pargana Mahal' displaying their banner obstructed Barabazar-Manbazar road (SH-4) at Hullung more from 06-00 hrs causing hindrance to the vehicles and passersby. The supporters were playing 'Dhamsa' and had their traditional weapons. They were asked to refrain from their activities but they did not pay heed to the word of Police rather continued their activities up to 18-00 hrs. Such of their activities cause a lot of problem to the common people as it is a busy road and huge number of people avail this road regularly.

Under the above circumstances, I therefore pray that a case may kindly be started against 30/35 unknown supporters of 'Bharat Jakat Majhi Pargana Mahal' under appropriate section of law for their act of offence.
