Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act , 2003 "subsequently electricity act-2007, to the effect that BIJOY BHUJIAN, S/O- LT. BUGI BHUJIAN, VILL-HIZLA, KOLBAID, P.S- BARABAOR, DIST- PURULIA was enjoying electricity unauthorizedly by direct hooking from nearest LT OH line through 2-Core flexible PVC cable and he has committed theft of electricity U/S 135(1)/a of the electricity (Amendment act-2007).

On 28.09.2018 I, Sri ANSHUMAN MITRA, A.E & S.M., BARABAOR CCC along with

- (1) Saheb Sutradhar, SAE(E), Barabazar CCC, WBSEDL
(2) Md Qasim Anasari, O.I, Barabazar CCC, WBSEDL

Entered into the premises of BIJOY BHUJIAN, S/O- LT. BUGI BHUJIAN, VILL-HIZLA, KOLBAID, P.S- BARABAOR, DIST- PURULIA and inspected his premises at 6:15 p.m.

During inspection, it was found that BIJOY BHUJIAN, S/O- LT. BUGI BHUJIAN, VILL-HIZLA, KOLBAID, P.S- BARABAOR, DIST- PURULIA was enjoying electricity illegally by direct hooking from nearest LT OH line through 2-Core flexible PVC cable in his premises at Hizla, Kolabaid with connected load of 0.071 KVA.

From the above arrangement he was using the following equipment:

01. 01 no Electric Bulb (60 watt)

Out of which I seized the following articles:

1. 2-Core flexible PVC cable (7 mtr. Approx) with hooking device and Holder.

Seizure list was prepared at site and accused person refused to sign. After process of inspection and seizure list we left the premises at about 06:40 p.m.

The said person has committed an offence U/S 135(1)/a of electricity act 2003 subsequently electricity (Amendment) act-2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
