1 SI Tufan Kumar Dawn (33), S/O- Abani Kanta Dawn, O/C Boro PS do hereby record this case as suomoto against approx 90/100 supporters of Bharat Jakat Majhi Pargana Mahal, and Bharat Jakat Majhi Pargana Juwan Mahal, Man Muluk to the effect that today on 24.9.18 at 06:05 hours receipt a telephonic information regarding obstruction of West Bengal state Highway road (SH Manbazar – Bandwan asphalt road via Boro (SH-05) at Kumari Bridge, of village- Khariduar under PS Boro Dist- Purulia with the banner of Bharat Jakat Majhi Pargana Mahal and Bharat Jakat Majhi Pargana Juwan Mahal without any prior information or permission. I diarised the information at Boro PS GDE No. 777 at 06:05 hours. Accordingly myself along with ASI Tapus Patra of Boro P.S and ASI Ananta Kumar Dey ,C/1481 Gadadhar Biswas, C/662 Dhananjoy Pandey, JC/1328 Somenath Patra, C/607 Barun Kumar Kuiry, C/819 Manik Chandra Dey Dutta, C/17 Monohor Kanti Sanmanta. C/736 Nikhil Ch Soren. C/494 Monoj Kumar Mura, C/117 Sanatan Sing Sardar, all of Jamtoria LC, left PS for Kumari Bridge. After reaching there at about 06:45 hours. I found that the road in front at Kumari Bridge, Khariduar which runs between Manbazar and Bandwun via Khariduar had been blocked by the supporters of Bharat Jakat Majhi Pargana Mahal, Man Muluk from 06:00 hours. The mob was unruly. They are creating pandemonium and causing huge Traffic congestion including Ambulances, Passengers busses, trucks and other passengers and goods vehicles making inconvenience to public. We requested and subsequently warned several times to remove the obstruction and to regularize the traffic flow. I tried to convince them but they were reluctant and obstinate to hear me. When the people assembling there turned in riotous mood and enhance their agitation vocally to a great extant the entire ambience on the road become very violent, having no other alternative way I declared the mob as unlawful assembly and commanded them to disperse accordingly but the unruly mob continued to be with the unlawful assembly, causing unlawful restraint to the vehicles and passersby and thus generated danger and obstruction in public way during this a hot altercation and followed by scuffling was made. They disobeyed our order as knowing us police personnel also and having no pay heed our order. But in compare to the mob we were insufficient in number to overpower them. So there was no option but to wait. We started waiting and trying to convince them to clear the road for the interest of common people but our entire endeavor went in air. By this way they blocked the road for 12 hrs and at last they withdrew it at around 18:00 hrs. On returning to Boro PS I do record Boro PS Case No- 41/18 dated- 24.09.18, U/S 143/147/149/186/283/341/353 IPC, Read with sec.18 of the west Bengal Highway Act. -1964 as suomoto against approx 90-100 supporters of Bharat Jakat Majhi Pargana Mahal, and Bharat Jakat Majhi Pargana Juwan Mahal, Man Muluk and directed SI Jotilal Mahato, In- Charge, Jamtoria I/C to investigate the case.
