Respected Sir,

In producing herewith one accd. Person Santosh Kr. Hembram (39 Yrs), S/O- Lt. Gahan Hembram of Vill- Lukuidih PS - Boro, Dist - Purulia with seizure of 33 (Thirty-three) sealed bottles of 80-U.P DILKHUSH Country Spirit each Bottle contains 375 ml., M.R.P. Rs. 22/- each, which was seized under proper seizure list.

I beg to submit that today (29.09.18) in between 18.05 hrs to 18.35 hrs a raid was conducted in the house of Santosh Kr. Hembram S/O- Lt. Gahan Hembram of Vill- Lukuidih PS - Boro, Dist - Purulia. On acting of secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling Country Spirit which is kept in his house. On demand he failed to produce any valid documents in respect of selling of liquor from his house. As such he was arrested at 18.35 hrs u/s 67 B.E. Act and also seized also the articles under proper seizure list in presence of witnesses, u/s 67 A (C) B.E. Act which enclosed here with. Out of seized articles one bottle as sample with sealed & labeled. During arrest the ground of arrest were duly notified issuing arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee.

The above noted arrested accd. Santosh Kr. Hembram (39 Yrs), S/O- Lt. Gahan Hembram of Vill- Lukuidih PS - Boro, Dist - Purulia committed offence u/s 46 A (C) B.E. Act. 1909 for un-authorized possession and sale of country spirit from his house at Lukuidih, P.S. Boro Dist- Purulia.

It may note here that during raid (1) C /181 Rabban Sekh, (2) JC/ 1021 Ananta Lohar accompanied me.

Under the fact and circumstanced I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against Santosh Kr. Hembram (39 Yrs), S/O- Lt. Gahan Hembram of Vill- Lukuidih PS - Boro, Dist - Purulia.
