I, SI Partha Kumar Bhunia, O/C Hura PS do hereby lodge this FIR as suomoto against 500 supporters of Bharat Jakat Majhi Pargana Mahal, Muluk Pargana to the effect that today i.e. 24.09.18 at around 06:15 hrs received a telephonic information that some person had blocked Bankura Purulia Road (NH 60A) near Lalpur more with the banner of Bharat Jakat Majhi Pargana Mahal without any prior information or permission and a huge numbers of vehicles including Public buses and State Buses got obstructed. Accordingly the fact noted in G.D. vide Hura PS G.DE. No- 940 Dtd- 24.09.18 and myself along with ASI Swapan Kumar Nandi and force rushed to the spot. We reached Lalpur More at 06.25 hrs. and found that a large numbers of vehicles were obstructed in a queue and approx 500 persons had blocked the road by placing big stones, cycles, motorcycles and they were sitting on the road with the banner of Bharat Jakat Majhi Pargana Mahal. The mob was unruly. I tried to convince them but they were reluctant and obstinate to hear me. All of them were armed with lathi, Tangi, Tabla and other deadly weapons. I asked them to disperse in loud and clear voice but they did not pay any heed to my word, during this a hot altercation and followed by scuffling was made. I declared them as unlawful assembly but they did not care a fig. But in compare to the mob we were insufficient in number to overpower them. So there was no option but to wait. We started waiting and trying to convince them to clear the road for the interest of common people but all our endeavor went in air. They willfully was doing this blockage with intent to injuriously affect the National Highway causing extreme inconvenience to common people violating our order without having any order either from any concerned authority. By this way they blocked the road for 12 hrs and at last they withdrew it at around 18:00 hrs.

Hence I do record Hura PS Case No-74/18 Dtd-24.09.18, U/S-147/186/283/341/353 IPC and Section 8B of National Highway Act 1956 as suomoto against approx 500 supporters of Bharat Jakat Majhi Pargana Mahal and directed SI Biswajit Sarkar to investigate the case.
