Lebu Chitrakar of village- Pakurhans, PS- Nanur, Dist- Birbhum, (2) Saptam Mal (22) @ Kalu S/O Mantu Mal of village- Jalandi, PS- Nanur, Dist- Birbhum, (3) Sukanta Mal @ Srikanta (25) S/O Bablu Mal of village- Jalandi, PS- Nanur, Dist- Birbhum, (4) Sagar Mal (25) S/O Lt. Jammuni Patuya of village- Pakurhans, PS- Nanur, Dist- Birbhum, (6) Dudhifal Chitrakar (20) @ Habal S/O Utpal Chitrakar of village- Pakurhans, PS- Nanur, Dist- Birbhum, (7) Ranjit Mal @ Magurfal (32) S/O Mukti Mal of village- Jalandi, PS- Nanur, Dist- Birbhum, to the P.S. in custody and lodged a complaint as Suo-Moto against the above noted accused persons to the effect that on 03/09/2018 at 00.05 hrs after getting a source information noted in G.D. vide this P.S. G.D.F. No-76 dtd- 3/9/18 that some suspicious character assembled near the north east position of Maya sorobar Jhalda Town under Jhalda P.S., Dist- Purulia for committing an organized crime, myself along with ASI Biswajit Kalindi (1) C/538 Dayamoy Mahato (2) C/1031 Pankaj Kr. Patra, (3) C/958 Madhusudhan Ojha (4) NVT-169 Manik Mahato (driver of govt. vehicle) all of Jhalda P.S. rushed nearby assembled place at the north east position of Maya sorobar Jhalda Town by govt. vehicle WH56C-8741 vide Jhalda ps CC no-2726/18 Dtd- 2.09.18. We approached to the P.O on foot by keeping vehicle at a distance of 500 meters away (approx) and surrounded the same quickly and surreptitiously. As it was odd hours of night and lonely place there was no local people. We heard suspicious human voice at a distance from 10/15 meters to converse among themselves in Bengali dialect. After having heard this myself along with my officer and forces challenged the suspicious character, as police party reached they started running for shelter and tried to fled away from the spot. Swapan Mal of village- Jalandi, PS- Nanur, Dist- Birbhum, (5) Anarul Patuya (33) S/O Lt. Jammuni Patuya of village- Pakurhans, PS- Nanur, Dist- Birbhum, (6) Dudhifal Chitrakar (20) @ Habal S/O Utpal Chitrakar of village- Pakurhans, PS- Nanur, Dist- Birbhum, (7) Ranjit Mal @ Magurfal (32) S/O Mukti Mal of village- Jalandi, PS- Nanur, Dist- Birbhum, and 3/4 others fled away from the spot. During search one improvised country made pipe gun loaded with one live ammunition 8 mm found in left side waist of Utpal Chitrakar (44) S/O Lt. Lebu Chitrakar of village- Pakurhans, PS- Nanur, Dist- Birbhum, and one Bhojali found left side waist of Saptam Mal (22) @ Kalu S/O Mantu Mal of village- Jalandi, PS- Nanur, Dist- Birbhum, one sabbal found at the right hand of Sukanta Mal @ Srikanta (25) S/O Bablu Mal of village- Jalandi, PS- Nanur, Dist- Birbhum, one knife at the left side of waist of Sagar Mal (25) S/O Lt. Swapan Mal of village- Jalandi, PS- Nanur, Dist- Birbhum, one bamboo lathi at the right hand of Anarul Patuya (25) S/O Lt. Jammuni Patuya of village- Pakurhans, PS- Nanur, Dist- Birbhum.

On interrogation the accused persons gave their names and address as on the overleaf and stated that they assembled there for committing dacoity on Jhalda- Baghmundi old road during this night on any merchandise truck or from any businessmen. On demand the above noted miscreant could not produce any valid license of any competent authority in favour of possessing illegal arms and ammunition and to acquire the same. So I arrested them informing the ground of arrest and prepared seizure list of all the articles which were seized and labeled from their possession and as well as from the P.O, duly signed by the police witnesses as there was no local witnesses available there. As it was evident during our raid the accused persons assembled at a solitary place and were preparing amongst themselves with weapons found in their possession for committing dacoity on Jhalda- Baghmundi old road, actually committed an offence punishable U/S- 399/402 IPC and 25/27/35 Arms Act. In view of this I arrested the above noted 07(seven) accused persons and seized the weapons from their possession by preparing seizure list on the spot duly signed by the witness and brought them to P.S at 03.15 hrs.

So, I therefore lodge a written complaint against a/ced. Persons namely (1) Utpal Chitrakar (44) S/O Lt.
