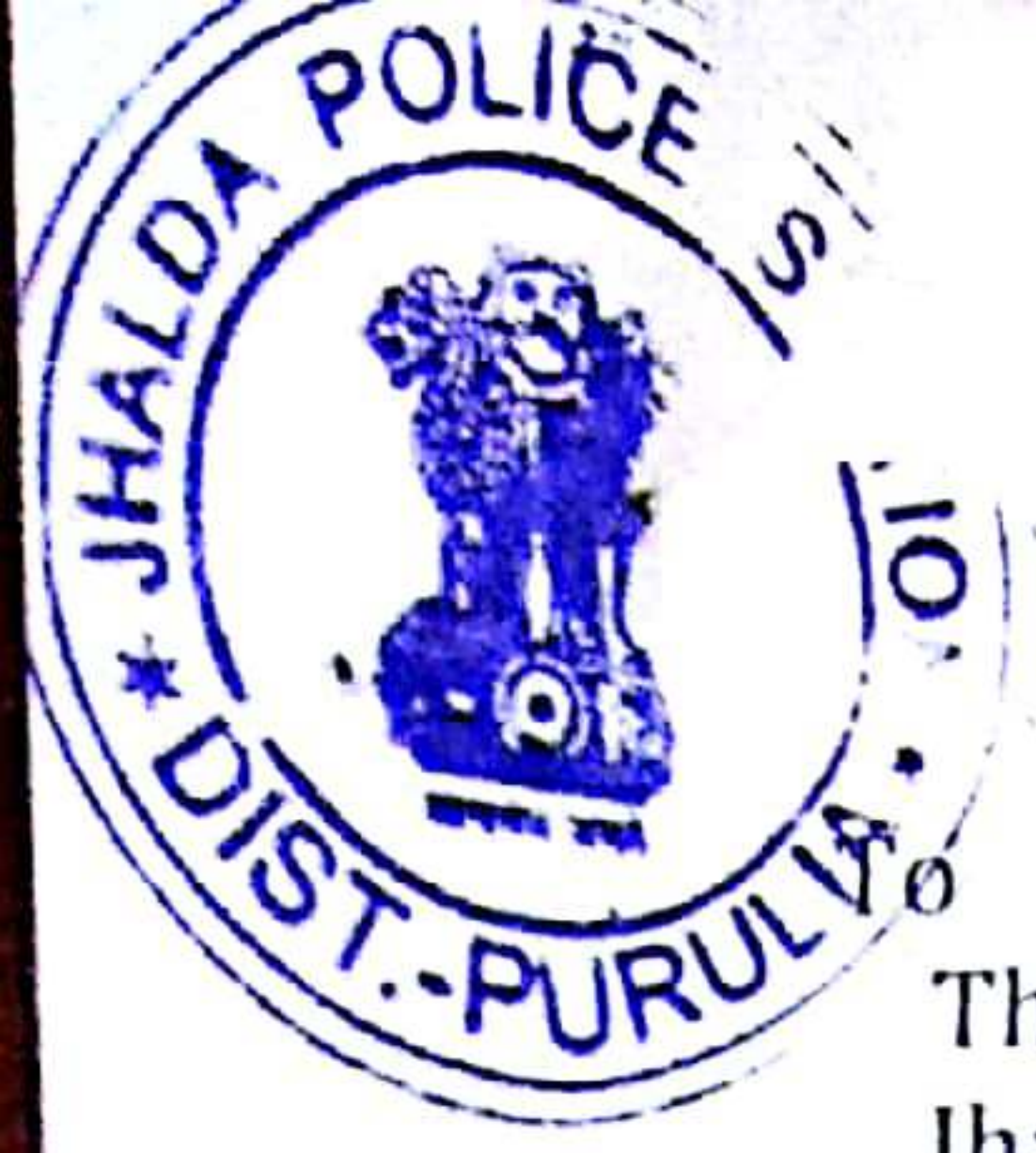

Sir,

In Producing here with one arrested accd. Person namely Chinibas Mandol (35yrs) S/O Late Sarat Chandra Mandol of vill Iloo, P.S. Jhalda, Dist. Purulia brought under arrest with seized article 01 plastic bag containing 14 (Fourteen) bottles of Dil Khush (Country sprit) each bottle 600 ml. from his possession. I do hereby lodged this written complain to the effect that on-08/09/2018 at 16:35 hrs. I received telephonic source information that one person selling (Country sprit) at Iloo Village. I inform the matter to I/C Jhalda P.S over Phone as per his direction myself along with ASI Biswajit kalindi, C/696- Gorapada Paul, J.C/1422-Abhijit Halder, J.C/1436- Ahammar Ansary, NVF-39- Lalit kishore Mahato vide C.C No. 2791 / 18 Dtd- 08/09/18 left for Iloo village to work out the information. We reached at Iloo Village at about 18:15 Hours and held raid in the house of Chinibas Mandol (35yrs) S/O Late Sarat Chandra Mandol of vill Iloo, P.S. Jhalda, Dist. Purulia, and found that the accused person selling Dil Khush in his premises accordingly I seized the 01(One) plastic bag containing 14 (Fourteen) bottles of Dil Khush (Country sprit) each bottle 600 ml. under proper seizure list duly signed by the witnesses as well as accused person with proper label. I search for local witnesses but found none.

Accordingly I arrested accd. Chinibas Mandol (35yrs), S/O Late Sarat Chandra Mandol of vill Iloo, P.S. Jhalda, Dist. Purulia having maintained all formalities after issuing arrest memo. On integration he confessed that he selling the said Dil Khush (Country sprit) to the villagers in lieu of money. On demand he could not produce any valid documents/license in favour of selling the same. So he committed offence punishable U/S - 46 (A) (c) of B.E. Act. 1909.

On return to P.S. along with accd. person and all seized articles. Put the accd. Person in the Lock UP after maintaining all formalities and seized articles kept in P.S. Malkhana and I submitted written complaint before I/C Jhalda P.S. to start a case against Chinibas Mandol (35yrs), S/O Late Sarat Chandra Mandol of vill Iloo, P.S. Jhalda, Dist. Purulia under proper section of law.
