Sir,

In producing here with the one arrested accused person namely Karim Ansary(24 yrs) S/O Nasir Ansary of village- Mosina, PS- Jhalda, Dist- Purulia along with one seized Tractor bearing Reg. No- WB55A/5125 attached with a sand loaded trolley, the fact in brief is that today(14.09.18) morning at about 05:15 hrs received a credible source information that one tractor was carrying sand illegally and coming from Jargo side & going towards Jhalda side. Accordingly, myself along with force left PS to work out the said source information. This refers to Jhalda PS GDE No- 494 Dated- 14/09/18 & Jhalda PS CC No- 2842 Dated- 14/09/18. Then, we intercept the said vehicle at Ichag More (under Jhalda PS) at about 05:45 hrs and found the tractor was tagged with a trolley being loaded with sand. On asked, the driver revealed his identity as mentioned earlier. On demand, he failed to produce any valid papers in respect of the Tractor which is attached with a Trolley as well as loaded sand though sufficient time was given. During interrogation, the driver of the said tractor confessed that he in convince with the owner of said vehicle (WB55A/5125) namely Pradip kr. Dutta S/O Kisan Dutta of Jhalda Anandabazar, ward No. 02, P.S. Jhalda, Dist. Purulia & others is carrying the said sand after received dishonestly from the bank of river Subarnarekha at Basuli Ghat (which is not a registered Ghat) & carry on in conceal it as stolen property for aiming business to deal for profit as habitually. Then, I SI Jayanta Maji arrested the accused driver of the said vehicle (as disclosed during interrogation) Karim Ansary(24 yrs) S/O Nasir Ansary of village- Mosina, PS- Jhalda, Dist- Purulia under proper arrest memo and also seized the Tractor (WB55A/5125) with attached sand loaded Trolley(approx 100 cft).

On return to P.S., Put the arrested accused person in the Lock UP after maintaining all formalities, kept the sand loaded seized vehicle at PS compound and I do here by submitting written complaint before you to start a case against 1) Karim Ansary(Driver) S/O Nasir Ansary of village- Mosina, PS- Jhalda, Dist- Purulia, 2) Pradip kr. Dutta(owner) S/O Kisan Dutta of Jhalda Anandabazar, ward No. 02, P.S. Jhalda, Dist. Purulia & others under proper section of law.
