The above-named complainant begs to state as follows :-

1.That the complainant has permanent house at village Sidhi,within p.s.Joypur, Dist. Purulia and under the jurisdiction of this court.

2.That the day of occurrence i.e on 27.08.2018 at about 7 A.M. all the accused persons by forming an unlawfully assembly with lathi, tangi trespassed into the khet bearing R.S.Plot no.1129,1130 & 1127 within Mouza Sidhi, which the complainant purchased by a registered sale deed bearing no.2837 dt. 16.05 1951,and they forcibly have ploughed upon the said plots,as a result paddy seed lings have been damaged which were transplanted by the complainant with his inhuman labour and by spending huge money.The complainant when protested against their illegal activities, then all the accused persons abused him in filthy languages not only that the accused nos.4&5 also instigated the accused nos. 1 to 3

to kill the complainant , then and there accused nos. 1 to 3 gave a tangi blow aiming the head of the complainant with a view to finish his life but any how the complainant was saved.

3. That the complainant has sustained loss of Rs.3,000/- for damage of the paddy seed lings. The witnessess came to the spot and witnessessed the occurrence,seeing them the accused persons flade away and at the time of leaving the place, the accused persons threatened the complainant by saying "Toke sesh korboi".

On the very day, the complainant went to O.C.Joypr P.S.to lodge a written complaint against the accused persons but they refused to accept the complaint. ~~Thereafter~~ <sup>Thereafter</sup> the complainant due to fear and to protect his life lodged a written complaint against the accused persons before the Superintendent of Police, Purulia but still now no action has been taken against the accused persons

It is, therefore, prayed that your Honour would be graciously pleased to send this petition of complaint to the O.C.Joypur P.S.,as contemplated u/s 156 (3) Cr.P.C. for investigation after treating it as F.I.R. for the interest of justice.
