On 15.09.2018 at about 11.30 AM I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 1. Ganesh Mahato, Gr1 TSH 2. Sristidhar Mahato, HG. TSH entered the premises of Mantu Mahato, S/O- Lt.
