Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Kiriti Halder s/o Lt. Nimai Halder, Vill +PO- Manihara, Dist-PURULIA has committed theft of Electricity U/S-135(1)(a) of the Electricity Act 2003,(Amendment) Act-2007.

On dated 18.09.2018 I received a secret complain over telephone Sri Kiriti Halder s/o Lt. Nimai Halder, Vill +PO- Manihara, Dist-PURULIA consuming electricity for his house illegally through byepassing the service cable.

On the basis of said complaint at about 1.25 pm. I, Sri MrinalChowdhury, Assistant Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with,

1) Sri Dipak Kr. Bhowmik, SAE, Kashipur CCC

3) Sri Sanjoy Garain, OE Kashipur CCC.

Entered the premises of Sri Kiriti Halder, and found that he is consuming electricity dishonestly by means of Tapping from service cable before entering the meter and the said point put in the wall with well furnished intensionally to resist actual consumption for his house. His con id-242041278.

Total Load found approx 1.5 KW (Pump-1, fan-3no, Refrigerator-1, TV-1, Light-4)

Then we disconnect his permanent connection and seized the following articles.

1. Tapping Point ---6 ft.(Approx)

After preparation of proper seizure list The seizure list are prepared at the site and the representative of accused person refuse to sign in the seizer list. The inspection team left the above premises at about 01.55 pm. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
