Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Biswajit Goswami(Pintu) S/O LT.Ambika Prasad Goswamii Vill+ PO- Ghat Rangamati Dist-PURULIA has committed theft of Electricity U/S-135(1)(a) of the Electricity Act 2003, (Amendment) Act-2007.

On dated 24.09.2018 | received a secret complain over telephone that Sri Biswajit Goswami(Pintu) S/O LT.Ambika Prasad Goswamii Vill+ PO- Ghat Rangamati Dist-PURULIA consuming electricity by means of hooking from nearest LT network of WBSEDCL.

On the basis of said complaint at about 1.50 pm. I, Sri MrinalChowdhury, Assistant Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with,

1)Sri Dipak Kr. Bhowmik, SAE, Kashipur CCC

2) Sri Sanjoy Garain, OE Kashipur CCC.

Entered the premises of Sri Biswajit Goswami(Pintu) S/O LT.Ambika Prasad Goswamii Vill+ PO-Ghat Rangamati Dist-PURULIA and found that Sri Goswami consuming electricity dishonestly by means of hooking from nearest It network of WBSEDCL. Then we disconnect his hooking wire with hooking device , seized the PVC wire 1.5 metre with hooking device along with one bulb and holder fitted with pvc wire . Load found-fan-2, cfl-2 nos, TV-1 Nos Total-0.3 KW.

After preparation of proper seizure list The seizure list are prepared at the site and the accused person refuse to sign in the seizer list. The inspection team left the above premises at about 02.20 pm. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
