Total Load found approx 1.4 KW ( Pump-1, fan-4no, Refrigerator-1, TV-1, Light-10) Then we disconnect his permanent connection and seized the following articles.

Tapping Point ---- 15 ft. (ApproX)

After preparation of proper seizure list The seizure list are prepared at the site and the representative of accused person refuse to sign in the seizer list. The inspection team left the above premises at about 05.55 pm. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.
