SI Mithun Kr Sar, O/C Kashipur PS do hereby lodge this FIR as suomoto against 150 supporters of Bharat Jokat Majhi Pargana Mahal, Muluk Pargana to the effect that today at around 06:25 hrs received a telephonic information that some person had blocked Kashipur Adra and Kashipur Chhatna main Road at Kashipur Hattola Traffic moch with the banner of Bharat Jokat Majhi Pargana Mahal without any prior information or permission and a large numbers of vehicles including Public buses got obstructed. Accordingly myself along with ASI Ananda Mandal and force rushed to the spots and found that a large numbers of vehicles were obstructed in a queue and approx 150 persons had blocked the road by placing big stones, cycles, motorcycles and they were sitting on the road with the banner of Bharat Jokat Majhi Pargana Mahal. The mob was unruly. I tried to convince them but they were reluctant and obstinate to hear me. All of them were armed with lathi, Tangi, Tabla, Bow and Arrow and other deadly weapons. I asked them to disperse in loud and clear voice but they did not pay any heed to my word during this a hot altercation and followed by scuffling was made. I declared them as unlawful assembly but they did not care a fig. But in compare to the mob we were insufficient in number to overpower them. So there was no option but to wait. We started waiting and trying to convince them to clear the road for the interest of common people but all our endeavor went in air. They willfully was doing this blockage with intent to injuriously affect the road causing extreme inconvenience to common people violating our order without having any order either from any concerned authority. By this way they blocked the road for 12 hrs and at last they withdrew it at around 18:05 hrs.

Hence I do record Kashipur PS Case No- 79/18 dtd - 24.09.18, U/S 147/186/283/341/353 IPC as suomoto against approx 150 supporters of Bharat Jokat Majhi Pargana Mahal and directed SI Abhijit Singha to investigate the case.
