P.S. Kendua, Dist-Purulia, having Consumer No. nil Meter No. nil
and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing
the energy meter i.e. U/S135(I) (n) was detected. The details of passing the arrangement was damage
installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his
house without energy registration in WBBEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- (1) Ceiling Fan, 02 (two) nos. each 80 watt
- (2) Table Light, 01 (one) nos. each 40 watt
- (3) C.P.L. 02 (two) nos. each 26 watt

Out of which I seized the following.

- (4) PVC cable, 02 (two) Cwt. 50 (Fifty) meter approx.

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left
the premises at 02.12 PM on 12.09.2018. The accused person has committed an offence
U/S135(I) (n) of the electricity act, 2003 subsequently electricity (Amendment) act- 2007.
