I SI Amit Masanta, O/C Kotshila PS do hereby lodge this FIR as suomoto against approx 60/70 supporters of Bharat Jakat Majhi Pargana Mahal to the effect that today at around 09.35 hrs received a telephonic information that some persons had blocked Ranchi -Purulia asphalt road (SH-4) near Kotshila Railway station with the banner of Bharat Jakat Majhi Pargana Mahal without any prior information or permission and a huge number of vehicles including Public buses and State Buses got obstructed. Accordingly myself along with ASI Ullash Kr. Chandra and force rushed to the spot at 09.55 hrs and found that a large number of vehicles were obstructed in a queue and approx 60/70 persons had blocked the road by placing bamboo, rope and they were sitting on the road with the banner of Bharat Jakat Majhi Pargana Mahal. The mob was unruly. I tried to convince them but they were reluctant and obstinate to hear me. All of them were armed with lathi, Tangi, Tabla and other deadly weapons. I asked them to disperse in loud and clear voice but they did not pay any heed to my word during this a hot altercation and followed by scuffling was made and also obstructed us in discharge of public functions. I declared them as unlawful assembly but they did not care a fig. But in compare to the mob we were insufficient in number to overpower them. So there was no option but to wait. We started waiting and trying to convince them to clear the road for the interest of common people but all our endeavor went in air. They willfully was doing this blockage with intent to injuriously affect the State Highway causing extreme inconvenience to common people violating our order without having any order either from any concerned authority. By this way they blocked the road for 7 hrs and at least they withdrew it at around 16:45 hrs.
