I SI Srikanta Mula, C/C Manbazar PS do hereby lodge this FIR as suomoto against approx 100 supporters of Bharat Jakat Majhi Pargana Mahal Muluk Pargana to the effect that today at around 05.25 hrs received a telephonic information that some persons had blocked Purulia Manbazar road at Rice mill more with the banner of Bharat Jakat Majhi Pargana Mahal without any prior information or permission and a huge number of vehicles including Public buses and State Buses got obstructed. Accordingly myself along with SI S P Patra, ASI Sudhir Tudu and force rushed to the spot at 06.25 hrs and found that a large number of vehicles were obstructed in a queue and approx 100 persons had blocked the road by placing bamboo, rope and they were sitting on the road with the banner of Bharat Jakat Majhi Pargana Mahal. The mob was unruly. I tried to convince them but they were reluctant and obstinate to hear me. All of them were armed with lathi, Tangi, Tabla and other deadly weapons. I asked them to disperse in loud and clear voice but they did not pay any heed to my word during this a hot altercation and followed by scuffling was made and followed by scuffling was made and also obstructed us in discharge of public functions. I declared them as unlawful assembly but they did not care a fig. But in compare to the mob we were insufficient in number to overpower them. So there was no option but to wait. We started waiting and trying to convince them to clear the road for the interest of common people but all our endeavor went in air. They willfully was going this blockage with intent to injuriously affect the State Highway causing extreme inconvenience to common people violating our order without having any order either from any concerned authority. By this way they blocked the road for 12 hrs and at least they withdrew it at around 18:00 hrs.

Hence I do record Manbazar PS Case No-51/18 Dtd-24.09.18 U/S-143/147/106/283/341/353 IPC read with 18 of W B State Highway Act, 1964 as suomoto against approx 100 supporters of Bharat Jakat Majhi Pargana Mahal and directed SI Uttam Kr Mondal to investigate the case.
