Sub: Complaint against Shri Dula Kumbhakar and others for violating the provisions of sections 34, 35 and 42 of Aadhaar (Targeted Delivery of Financial and other Subsidies, Benefits and Services) Act, 2016, sections 418, 420 and 468 of IPC and section 66(C), 66(D) of IT Act and any other relevant acts.

It has come to the knowledge of UIDAI that one Shri Dula Kumbhakar, s/o Sankal Kumbhakar, a resident of Boludih, Palsola, Puruliya, West Bengal - 723131 has committed an act of impersonation by wilfully allowing his fingerprints to be used for the generation of an Aadhaar identity of another person.

2. It is further learnt that the fingerprint of said Shri Dula Kumbhakar was wrongfully used for enrolment of one Subal Kumbhakar of Boludih, Manbazar - 1, Puruliya, West Bengal - 723131, whose Aadhaar number was issued after enrolment on 16-02-2014. In furtherance of the wrongful act, the said Dula Kumbhakar tried to fraudulently update the biographic details of Shri Subal Kumbhakar fraudulently.

3. The aforesaid acts of Mr. Dula Kumbhakar and others are in direct contravention of sections 34, 35 and 42 of the Aadhaar (Targeted Delivery of Financial and other Subsidies, Benefits and services) Act, 2016, sections 418, 420 and 468 IPC and sections 66(C) and 66(D) of IT Act and any other relevant acts.

4. Accordingly, an FIR may please be registered and immediate consequential action be undertaken.
