This is to inform you, as reported by Sri Subedar Roy, Security Guard of Ranipur Colliery that on 01.9.2018 in night hours transformer coil & about eight feet cable fitted with transformer had been stolen away by the miscreants from 5 KVA Transformer by opening cover which was installed at Filter Plant of Ranipur Colliery for which electric supply of colonies at Ranipur Colliery had been disrupted and company suffered financial loss due to this theft of Coil.
