Sir, I do hereby lodge complaint empowered by enabling the electricity act 2005 duly ammended on 2007 that to the effect (06-09-2018) Sri Bhagirath Majee s/o - Lt Ananda Majee of vill - Bora PS - Neturia Dist - Purulia was enjoying electricity unauthorisedly by means of direct hooking from nearest LTOH of WBSEDCL and due to this reason he has committed theft of electricity up - 135(i)(a) of the electricity act 2003 ammended on 2007.

On (06-09-2018) at about 16:50 hrs I Goutirmoy Dass, s/o Lachman Dass, Station Manager Saltore Coustomer Care Center along with ① Sri Pradip Choudhury DM RNPD, ② Sri Suman Banerjee Sr. SAE RNPD, ③ Sri Kanai Sasmal LM Saltore coustomer care center ④ Sri Goutam Kr. Pandey Hg TSH of saltore coustomer care center entered at the premises of Sri Bhagirath Majee for routine inspection while it is observed that Sri Majee was enjoying electricity unauthorisedly (dishonestly) by means of direct hooking from nearest LTOH of W. WBSEDCL He used 2 core PVC cable, 6 sqmm along with hooking device for this perpowse.

I seized the following as a token from the above arrangement -

- ① PVC cable 2 core 6 sqmm - 8.5 meter (approx) with hooking device
- ② Bulb with holder - 01 nos 100 w

Seizure list was prepared at the site and the representative of accused person refused to sign on it. The inspection team left the premises 17:35 hrs on 06-09-2018

Hence the accused person has committed an offence u/s 135(1)(a) of the electricity act 2003 duly amended on 2007.
