Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. person namely Dilip Bouri @ Khoru (30) S/O- Lt. Manbodh Bouri of village Jamduara, PS-Raghunathpur, District- Purulia with seizure of (1) 05 pcs. Sealed bottles of Dilkhush country spirit containing 600 ml. each and (2) 14 pcs. Sealed bottles of Dilkhush country spirit containing 375 ml. each which were seized under proper seizure list.

I beg to submit that today (08.09.18) at 18:45 hrs while myself along with force were performing anticrime evening mobile duty near Sarbari More, received source information that one Dilip Bouri @ Khoru (30) S/O- Lt. Manbodh Bouri of village Jamduara, PS-Raghunathpur, District-Purulia has illegal stock & selling of liquor in a chala ghar shaded by straw beside Subhash More under PS Neturia. On receiving the information, I informed the matter to you and as per your instruction myself along with force proceed to Subhash More for work out the information. At 19:15 hrs after reaching at Subhash More held raid in the chala ghar shaded by straw of Dilip Bouri @ Khoru (30) S/O- Lt. Manbodh Bouri of village Jamduara, PS-Raghunathpur, District- Purulia which is situated beside Subhash More to Santuri pitch road at Mouza Bansboni under PS Neturia and found that the above noted person was keeping / selling liquor which were kept in his chala ghar, on demand Dilip Bouri @ Khoru failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents . As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also (1) 05 pcs. Sealed bottles of Dilkhush country spirit containing 600 ml. each and (2) 14 pcs. Sealed bottles of Dilkhush country spirit containing 375 ml. each which were seized under proper seizure list duly signed by witnesses and labeled at the time of arrest. During arrest the ground of arrest was duly notified, issuing arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Dilip Bouri @ Khoru (30) S/O- Lt. Manbodh Bouri of village Jamduara, PS-Raghunathpur, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for

unauthorized possession and sale of liquor.

It may note here that during raid 1. C/1224 Gajan Murmu, 2. C/448 Subhankar Mondal & 3. C/382 Bipad Taran Chattarjee all of Neturia PS accompanied me.

Under the fact and circumstances I therefore pray that a specific case may kindly be started against Dilip Bouri @ Khoru (30) S/O- Lt. Manbodh Bouri of village Jamduara, PS-Raghunathpur, District- Purulia under proper section of law.
