Sir,

I do hereby lodge complaint empowered by enabling the Electricity act 2003 duly amended on 2007 to the effect that on dated-15-09-18 Sri Santiram Bawu s/o - Lt Gurupada Bawu of Vill-Sarbaru, PS-Neturia, Dist-Purulia was enjoying Electricity unauthorisedly i.e. by direct hooking from nearest LTOH line of WBSEDCL and due to that reason he has committed theft of electricity u/s 135 (1) (a) of the Electricity act.

On dated-15-09-18 at about 12:05 hrs I Goutimoy Dass station manager Salfore CCC along with ① Sri Pradip Choudhury, Divisional Manager ② Sri Nitish Kumar, Assistant Engineer (IT&C) of Raghunathpur Division ③ Sri Goutam Kumar Pandey, Hg TSH ④ Sri Satya Rajwar, Sr. TSH entered the premises of Sri Santiram Bawu & inspected the premises. During inspection theft of electricity was detected. i.e. he was using electricity dishonestly by drawing illegal hooking from nearest LTOH line of WBSEDCL i.e. u/s 135 (1) (a) was detected.

From the above arrangement he was using the following electrical equipment viz ① Electric Fan - 02 nos (75 watt each) ② Electric Bulb - 02 nos (100 watt each) ③ TV - 01 nos (150 watt) out of which I seized the following -
