Sir, I do hereby lodge complaint empowered by enabling the Electricity act 2003 duly ammended on 2007 to the effect that on dated - 15-09-18 Sri Ajay Bawu s/o - Sitaram Bawu of Vill - Sarbari, PS - Neturia, Dist - Purulia was enjoying Electricity unauthorisedly i.e. by direct hooking from nearest LTOH Line of WBSEDCL and due to that reason he was committed theft of electricity u/s 135 (1) (a) of The Electricity act.

On (15-09-18) at about 12:30 hrs I Goutirmoy Das station manager, Sattore CCC along with ① Sri Pradip Choudhury, Divisional Manager ② Sri Nitish Kumar, Assistant Engineer (IT&C) of Raghunathpur Division ③ Sri Goutam Kr. Pandey, Hg. TSH ④ Sri Satya Rajwar, Sr. TSH of Sattore CCC entered the premises of Sri Ajay Bawu and inspected the premises. During inspection theft of electricity was detected i.e. he was using electricity dishonestly by drawing illegal hooking from nearest LTOH Line of WBSEDCL i.e. u/s 135 (1) (a) was detected.

From the above arrangement he was using the following electrical equipment viz ① Electric bulb - 02 nos (100 watt each) ② Electric Fan - 01 nos (75 watt) ③ LED Lamp - 03 nos (9 watt each) out of which I seized the following -
