Sir,
I do hereby lodge complaint empowered by enabling the Electricity act 2003 duly amended on 2007 to the effect that on dated - 15-09-18 Sri Golak Bawu sp - Lt Khandu Bawu of Vill - Sarbari, PS - Neturia, Dist - Purulia was enjoying Electricity unauthorisedly i.e. by direct hooking from nearest LTOH line of WBSEDCL and due to that reason he has committed theft of electricity u/s 135(1)(a) of The Electricity act.

On (15-09-18) at about 13:00 hrs I Protimoy Das station manager Saltore ccc along with ① Sri Pradip Choudhury, Divisional manager ② Sri Nitish Kumar, Assistant Engineer (IT&C) of Raghunathpur Division ③ Sri Goutam Kumar Pandey, Hq. TSH ④ Sri Satya Rajwar, Sr. TSH of Saltore ccc entered the premises of Sri Golak Bawu and inspected the premises. During inspection theft of electricity was detected i.e. he was using electricity dishonestly by drawing illegal hooking from nearest LTOH line of WBSEDCL i.e. u/s 135(1)(a) was detected.

From the above arrangement he was using the following electrical equipment viz ① Electric Fan - 01 nos (75 watt) ② Electric bulb - 02 nos (100 watt each) ③ LED Lamp - 03 nos (9 watt each) out of which I seized the following -

- ① Two core PVC cable with hooking device of length 60 ft approx.
- ② One no Electric bulb with holder - 100 watt
