Sir, I am Ram Brij Narain s/o Rati-shiv Mangal Narain of Andanga P.S. Neturia Dist. I wish to state that on 12/9/2018 at about 12 AM when I was at my shop, three miscreants namely (1) Nanku Ranbidas s/o Rati Indradeo Ranbidas (2) Rakesh Ram s/o Rati Deo Ram and (3) Ravinder Yadav s/o Ram Sudarup Yadav all of Andanga came to my shop and abused me in filthy language while protesting they became agitated and started to assault me by fist and blows subsequently they fell me on the ground and pressed my throat for attempt to ~~kill me~~ and assaulted by road boys I sustained grievous injuries and cut injury on my left eye ~~and~~ the assaulted ~~by~~ me over my body after hearing here and there my wife Sumitra Devi came to assist me but the miscreants also assaulted my left eye by fist and blows when some local persons came to the spot they fled away and still now they threatening to kill me, in lodging complaint delay for my treatment
