I myself along with ASI Indrajit Chakrabarty, ASI Atanu Das, SI Satmughna Mahato, SI Sibsankam Pal, others officers & force as per <sup>Spl</sup> G.O. no-03/18 to 07/18 at 6/9/18 and G.D.No-176 dt. 6/9/18 left PS to perform L/O duty at 08:35 hrs to maintain peace during the entire process vide para ps G.D.No-176 dt. 6/9/18.

The process was going on peacefully & smoothly. As per order of Ld. SDEM, Raghunathpur prohibitory order u/s-144 CrPc was promulgated in an area around 200mtrs from the office of Panchayat Samity, Para. We are performing duty near Para B.P.H.C. to enforce the said order. Suddenly at about 11:30 hrs a riotous mob of around 150/200 persons being armed with lathi started approaching towards the prohibitory zone. We obstructed them and told them that none other than bonafied persons will be allowed to enter the prohibitory zone. They did not heed my words. Moreover they became furious & tried to enter into the prohibitory zone. Then finding no other alternative I myself along with force pushed them back. But they did not retreat. Thereafter they started pelting brick bats, towards us. Resulting which some police persons received injury. Then we chased them & dispersed. During retreat they left they left the bamboo sticks on road. I seized 06 (Six) bamboo lathi each measuring about 5ft & some brick bats from P.O.

As they after forming riotous mob obstructed govt-duty & violated the prohibitory order of Ld. SDEM, Raghunathpur & caused injuries of some police personnel, they are liable for prosecution u/s-147/148/149/186/353/332/188 IPC.

Therefore I started this case suo-moto against unidentified 150/200 persons u/s-147/148/149/186/353/332/188 IPC. SI Sibsankam Pal will investigate the case.
