Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act, 2003 to the effect that **MD.Sakil, S/O-Late MD Kalim of VILL-Para(Muslim Para) ,P.S.-Para**, the user of the electric has committed an offence of theft of electricity under section 135 (1) (a) of Electricity Act, 2003 read with amendment of Electricity Act, 2007.

On 11.09.2018 at about 3:10PM, I GOUTAM KUMAR MANDAL, S.M. of DUBRA PARA C.C.C, along with Mr. Avishek Das, SAE(E), Dubra Para CCC and MR Mathura Saha, Manager, (F&A), PRO, Ashutosh Sharma, SAE(E), PRO, Purulia Regional office, WBSIEDCL inspected the premises of **MD.Sakil, S/O-Late MD Kalim of VILL-Para(Muslim Para) ,P.S.-Para** WBSIEDCL. During inspection it was found that the said **MD.Sakil**, was enjoying electricity unauthorizedly by direct hooking by cable as hooking arrangement from WBSIEDCL's nearest low tension over head line for running his 02nos AC, 07 nos ceiling fan, 02nos refrigerator, 01 no cooler, 01 no TV, 01 no washing machine, 10 nos CFL of approx load 4.615 KW for domestic purpose, which is an offence u/s. 135 (1)(a) of Electricity Act, 2003 read with the amendment of Electricity Act, 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSIEDCL. The inspection team left the site at about 3:30pm.

As **MD.Sakil, S/O-Late MD Kalim of VILL-Para(Muslim Para) ,P.S.-Para, Dist-Purulia** has committed an offence of theft of electricity under section 135 (1)(a) of Electricity Act, 2003 read with amendment of Electricity Act, 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
