During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by direct hooking from LT wire by PVC Cable

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- ① One fan → 80 watt
- ② LED BULB → 20 watt

Out of which we seized the following:

PVC wire with hooking device (10m Approx)
