Entered the premises of DHIREN MONDAL, S.O- Bishweswar Mondal of Village- Baisyakuli, P.O- Para, P.S- Para, Dist-Purulia. and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by tapping from incoming service cable. User - Dhiren Mondal

Consumer - Bishweswar Mondal, ID - 242015089, meter no - L4602497 (Landis)

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- i) Fan - 07 nos (80x7) = 560 watt , ii) Bulb - 06 nos (100x1) + (20x5) = 200 watt
- iii) TV set - 120 watt

Out of which we seized the following:

- i) Single phase meter with bypass incoming service cable, meter no - L4602497 (Landis)
