I ASI Pradip Dutta of Purulia (M) PS, Dist-Purulia do hereby lodge a complaint that today (02.09.18) at 06:05 hrs. received a telephonic information from duty officer of Purulia (M) PS regarding met an road accident at Podlara village on Purulia -Barakar road and obstruction the said road by unknown villagers. This refers to Purulia (M) PS GDE No-42 date-02.09.18. I along with force rushed to the spot with govt vehicle having Reg No-WB56C/5713 and found that the road has been blocked by gathering about 150 unknown villagers of Podlara and other pedestrians. Vehicular traffic was disrupted. It is learnt that some times ago an accident met by an unknown Pick-up van and due to this 2 female members of Podlara village were injured and shifted to Purulia Sadar Hospital. Out of them one has been expired. Over this issue the unknown villagers obstructed the road (SH-05). They raised slogans using slang language against police and started to throw stone, bricks etc. upon the police persons over this issue. As result I along with other force were sustained injuries and police vehicle has also been damaged. I tried to convince the peoples and requested to withdraw the road block but they did not pay heed rather than the mob became continuing their business. After prolonged discussion with them they withdrew the road blocked at 10:30 hrs. and vehicular traffic became normal.

As those persons have committed offence u/s-143/323/427/186/353/332/333/283 IPC & 18 WB Highway Act. 1964 & 3 PDPP Act I would request you to start a specific case against them.
