Sir.

In producing herewith 02 accused persons namely (1) Chintu Khemundu (19 yrs) s/o Chandra Khemundu of Lohaba, PS- Nandapur, Dist-Koraput, Orissa & (2) Jinu Ghunta (33 yrs) S/O Manika Ghunta of Kurumaput, PS- Nandapur, Dist- Koraput, Orissa under arrest and seized articles (1) One white coloured plastic bag loaded with 23 KG 300 Gm Cannabis/Ganja (2) 03 akasi coloured envelope containing 100 gm each of loose Cannabis/Ganja which have been collected from said bag as sample & (3) one Maruti Alto red coloured car having registration number OR 02AK1670 under proper seizure list sealed and labeled, duly signed by the witnesses and accused persons, I SI Tapas Mishra, of Purulia (M) PS do hereby lodge this complaint against the above noted accused persons for committing an offence punishable U/S 20 (b)(i)/29 NDPS Acr 1985. Today (28.09.18) at 18:35 hrs. when I along with my accompanying force namely (i) C/809 Madhusudan Mahato, (ii) C/726 Dipankar Mahato (iii) C/437 Subal Mandal and C/01 Ashok Chakrabarry all of PLA (M) PS with Govt. vehicle WB26C-5298 were performing NAKA CHECKING duty at Chengi More(Beside Tata road) vide PLA (M) PS C.C. No. 2322/18 dtd. 28.09.18 at about 18.25 hrs detained 02 persons namely (1) Chintu Khemundu (19 yrs) s/o Chandra Khemundu of Lohaba, PS- Nandapur, Dist- Koraput, Orissa & (2) Jinu Ghunta (33 yrs) S/O Manika Ghunta of Kurumaput, PS-Nandapur, Dist-Koraput, Orissa who were coming from TATA side towards Purulia town by driving a vehicle having reg no OR 02AK1670 and found that they were carrying one white colour poly sack on the back side seat of their vehicle. One being asked they stated that they were carrying said cannabis/Ganja in order to sale in Purulia side area. Arranged proper guard with the help of my accompanying force and informed the matter to my superiors over my mobile phone.

Thereafter, O/C, Purulia (M) P.S, C.I Sadar Purulia reached on the spot with electronic measuring articles and investigation kit. I issued notice upon the accused persons asking him whether they are willing to be searched by me in presence of an Executive Magistrate or a Gazetted Officer. In reply of the notice, detained persons gave their willingness in writing to be searched in presence of an Executive Magistrate, accordingly OC Purulia (M) PS informed to Sri Dibya Jyoti Das, BDO Purulia-I(Exe. Magistrate) with a request for search and seizure as per provision of section 50 of NDPS Act. After a while two public witnesses namely 1)Israk Ansari S/O Junabali Ansari of Vill-Uparjari, P.S Arsha, Dist. Purulia (2) Mansoor Ansari S/O Juneruddin Ansari of Vill-Misirdih, P.S Arsha, Dist. Purulia became ready to assist us in conducting search & seizure. At abour 19.35 hrs BDO Purulia-I arrived at the spot and disclosed his identity and explained the reason for arriving there. After his arrival I started search & seizure process at the PO. Then I offered the said detained persons to search our persons before get them searched.

Accordingly they conducted search of our Police persons but nothing was found except our official belongings and accordingly. I prepared NIL seizure list in presence of Sri Dibya Jyoti Das, B.D.O Purulia-I and detained persons. Thereafter at first I with the help of force searched above noted Chintu Khemundu & Jinu Ghunta and their belongings at the spot. During search of them found One white coloured Poly sack (BASTA) packed with 23 Kgs & 600 grams including sack Cannabis/Ganja from the back seat of the vehicle. As per direction of BDO.Purulia-I, I opened some portion of sack and found Cannabis/Ganja in this sack. Accordingly I seized the said bag under proper seizure list duly signed by the public witnesses, police witnesses and accused persons in presence of BDO Purulia-I after taking sample in 03 envelopes each containing 100 gm Cannabis/Ganja. Also packaged, scaled and leveled the same at the PO with the help of accompanied force and made over one copy of seizure list to the accused persons. I also seized one Marun Alto red coloured car having registration number OR 02AK1670 shows on the number plate having from the possession of above noted Chintu Khemundu & Jinu Ghunta. The Cannabis/Ganja is prohibited narcotic drugs which they were dealing in lieu of money that violating Sec. 20(b)(i)/29 NDPS Act 1985. There is no question of having any because in respect of possessing the same, accordingly I arrested them. Informed them ground of arrest, prepared memo of

were done between 19.55 hrs and 22.15 hrs under direct supervision of BDO Purdia-I and CI Sadar, Purulia with sufficient light.

I pray before you kindly a specific case may kindly be started under proper section of law against arrested accused persons namely (I) Chintu Khemundu (19 yrs) s/o Chandra Khemundu of Lohaba, PS-Nandapur, Dist-Koraput, Orissa & (2) Jinu Ghunta (33 yrs) S/O Manika Ghunta of Kurusnapur, PS-Nandapur, Dist-Koraput, Orissa for its investigation.
