In producing herewith one arrested aced. person namely Shyamapada Rajwar (50) S/O- Lt Bhikhakar Rajwar of Vill- SeneraAmra , PS- Purulia (M), District - Purulia with seized articles (1) 60(Sixty) sealed bottles of Country Spirit styled as DILSE each Bottle contains 600 ml 2) 05 (five) empty bottles of Country Spirit styled as DILSE each 600ml.3)01 (one) bottle taken as sample out of SL NO 1 which were seized under proper seizure list.

I beg to submit that today (29/09/18) in between 19.25 hrs to 19.35 hrs during special raid duty vide CC NO 2335/18 acting of a secret source information myself along with force conducted raid in the tea shop of Shyamapada Rajwar S/O- Lt Bhikhakar Rajwar of Vill- SeneraAmra , PS- Purulia (M), District - Purulia and found that he is selling DILSE from his tea shop and on being asked he failed to produce any documents in support of selling DILSE and cannot gives any satisfactory answer for such type of activities. Hence I seized (1) 60(Sixty) sealed bottles of Country Spirit styled as DILSE each Bottle contains 600 ml 2) 05 (five) empty bottles of Country Spirit styled as DILSE each contains 600ml.3) 01 (one) bottle taken as sample out of SL NO 1 under proper seizure list and arrested him .as he committed offence u/s 46 A (c) B.E.Act. 1909 for unauthorized possession and sale of DILSE from his tea shop..

Under the fact and circumstanced I therefore pray a case u/s 46 A (c) B.E.Act. 1909 may kindly be started against Rajwar (50) S/O- Lt Bhikhakar Rajwar of Vill- SeneraAmra , PS- Purulia (M), District - Purulia and arrange for its investigation.
