I, SI Dipankar Sarkar, O/C, Purulia (T) PS, Dist- Purulia, do hereby lodge complaint *Sas-mata* against arrested accused (1) Pradeep Singh (35 yrs) s/o Gopal Singh of A/156, Sector - 1, Kankarkhera, PS- Kankarkhera, Dist- Meerut, U.P., (2) Dipak Kumar Baid (28 yrs) s/o Lt Rajesh Kumar Baid of 771, Bada, RR Block, Naveen, PS- Shahdara, Dist- Shahdara, Delhi - 32, (3) Adit Nag (24 yrs) s/o Lt Sanjay Nag of B/18B, Samik Bihar, Sardhana Road, Kankarkhera, PS- Kankarkhera, Dist- Meerut, U.P. and brought under seizure (1) 02 (two) metallic 7.65 mm pistol approx 8" in length, one was loaded with 6 pieces 7.65 mm live ammunition by Magazine and another was loaded with 7 pieces 7.65 mm live ammunition by Magazine, (2) 24 numbers different Gold ornaments (07 chains, 02 Chhiks, 03 Lockets & 12 Ear ring/Dool/Phool), to the effect that today (10.09.18) at 12:45 hrs, received a source information that above noted accused persons are moving suspiciously near Purulia Station area. This refers Purulia (T) PS GDR No. 533 dated 10.09.18.

On getting this information I consulted with my superiors and making a police team along with (1) SI Dipankar Biswas of Purulia (1) PS, (2) ASI Guriam Kr Bangal of do, (3) ASI Stimanta Singh Sardar of do (4) C/983, Radha Kanta Kishu of do, (5) C/110, Uday Bhushan Ballav (vide Purulia (T) PS CC No 2735/18), left to work out the information. At 13:15 hrs we reached and cordoned the said area as identified by source and proceeded towards above named three accused persons. I asked them regarding their identities and reason for coming in Purulia town area. But all of them replied incoherently for which they became more suspicious. I asked them that they would be searched, when they all tried to flee away. However, we the police party could be able to detain them. Then I offered them to search our persons before get them searched when two independent witnesses were present there. But, they denied to search us. Then, at first I searched said Pradeep Singh and found one 7.65 mm firearm loaded with 06 rounds of 7.65 mm live ammunitions (with magazine) kept concealed on the left side waist under his wearing full pant covered by wearing shirt in his exclusive possession. On demand he failed to produce any document/authority for possessing and carrying such firearm & ammunitions. From his Rt. pocket, 08 pieces different Gold ornaments were recovered in which maximum were with tag of shop. On demand he also failed to produce any document for possessing those ornaments. After that, I searched said Dipak Kumar and found one 7.65 mm firearm loaded with 07 rounds of 7.65 mm live ammunitions (with magazine) kept concealed on the left side waist under his wearing full pant covered by wearing shirt in his exclusive possession. On demand he failed to produce any document/authority for possessing and carrying such firearm & ammunitions. From his Rt. pocket, 07 pieces different Gold ornaments were recovered in which maximum were with tag of shop. On demand he also failed to produce any document for possessing those ornaments. At last I searched said Adit Nag and from his left pocket, 09 pieces different Gold ornaments were recovered in which maximum were with tag of shop. On demand he became fail to produce any document for possessing those ornaments. They all stated that, those ornaments are looted articles as they have committed dacoity at Guini Gold Jewelry shop near Coke Oven PS, Durgapur, on 09.09.18 by using those firearms with their other associates. I contacted with OC Coke Oven PS, Durgapur, over phone and could know that, such incident is happened there. They also stated that, they have committed such type of crimes at various places in India with their other associates.

I prepared seizure lists of all the seized articles duly signed by the accused persons, local witnesses and my accompanying officer and forme and duly labeled.

For the above grounds I arrested all the above noted three accused persons and took in to my custody.

On my arrival back to PS along with the arrested accused persons and seized articles I started Purulia (T) PS Case No 125/18 dated 10.09.2018 U/S 379/411/413 IPC & 25/27/35 the Arms Act, against accused persons namely (1) Pradeep Singh (35 yrs) s/o Gopal Singh of A/156, Sector - 1, Kankarkhera, PS- Kankarkhera, Dist- Meerut, U.P., (2) Dipak Kumar Baid (28 yrs) s/o Lt Rajesh Kumar Baid of 771, Bada, RR Block, Naveen, PS- Shahdara, Dist- Shahdara, Delhi - 32, (3) Adit Nag (24 yrs) s/o Lt Sanjay Nag of B/18B, Samik Bihar, Sardhana Road, Kankarkhera, PS- Kankarkhera, Dist- Meerut, U.P. and their associates, and endorsed SI Partha Pratim Chakraborty to investigate the case.
