I do hereby lodge complaint empowered by enabling the electricity act-2003 subsequently electricity (Amendment) act-2007 to the effect that Gopal Banerjee was enjoying electricity at his said shop of Purulia bus stop unlawfully i.e. by passing of wires by means by cutting of incoming service connection cable and due to this reason he has committed theft of electricity U/s 135 of the electricity (Amendment) act-2007 on 12/09/18 at 4:00 PM

Entered the premises of (shop) Gopal Banerjee, VIII Avenue, Purulia Bus stop P.S. Purulia (T), Dist- Purulia, having Consumer No. 20449252, Meter No. P1773063 and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S 135(D)(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and tap 2 (two) piece of wire by which electricity directly flow to his home without energy registration in W.B.S.E.D.C.L. energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Refrigerator - 01 no.
- 2) Tubelight - 01 no.
- 3) Fan - 01 no.

Out of which I seized the following.

PVC 2 wire service connection cable along with by-passing arrangement - 06 ft (approx)

Seizure list was prepared at the site and accused person refuse to sign/signature. The inspection team left the premises at 4:30 PM on 12/09/18. The accused person has committed an offence U/S 135(D)(b) of the electricity act-2003 subsequently electricity (Amendment) act-2007.
