In proceeding herewith of above, arrested accused persons namely (1) Manu Sha @ Jabit (45 yrs) s/o Somanan Sha of Mukundapur, 28 Jaspur, Dist- Purulia, (2) Hama Sha (32 yrs) s/o Li Hamra Sha of dist. (3) Kurban Sha (30 yrs) s/o Kurnam Sha of dist with following seized articles (1) One country made improvised firearm loaded with one round live ammunition (2) One exocet & Nylon rope about 25 feet length (3) (i) Two shot (4) one small torch (5) One Lathi having 4 ft length (6) One iron Rod (7) One iron cutter locally known as 'A' (8) one 14/09/2018 at 21:45 hrs in course of an investigation made Purulia (T) PS t/c 12B No 776 dt 14/09/2018 I received were information from a source that a gang of criminals comprising of 9/10 headed under the leadership of Manu Sha @ Jabit s/o Somanan Sha of Mukundapur, 18 years, Dist- Purulia, were armed with deadly weapons were gathered at the North-West corner of the bank of Arindhu with a view to commit dacoity at the houses in Arindhu area.

Accordingly I informed the matter to O/C Purulia (T) PS, over phone and contacted with all night patrolling officers, according to all I immediately along with source and SI Rangshi Badru Mondal, C/246, Chanchal Colony, C/202, Samay Colony, 10/9/1, Deonihari Ghat, NTP/230, Partha Mondal and others, left to work out the information with Ghat vehicle No. WB-94-512F. At 22:30 hrs we reached at the place where the accused were assembled and preparing themselves for committing dacoity. From a distance of about 50 yards we arrested them. Their whispering came to our knowledge regarding committing of dacoity at the houses in Arindhu area. We crawled closer to them and disclose our identity and asked them to surrender; at that time, they all started to fled away, we chased them by using signal light device. After a hot chase we could catch up apprehend (1) Manu Sha @ Jabit (45 yrs) s/o Somanan Sha of Mukundapur, 28 Jaspur, Dist- Purulia, (2) Hama Sha (32 yrs) s/o Li Hamra Sha of dist. (3) Kurnam Sha (30 yrs) s/o Kurnam Sha of dist, as identified as a gangster. On further interrogation they stated that they along with (1) Sh. Aman Ali (aged 25 yrs), Purulia, (2) Sh. Biru of Haldi, PS - Haldi and 3-4 unknown others were assembled there and preparing themselves for committing dacoity at the houses in Arindhu area. We searched the above persons and following items were recovered from their possession, as (1) one country made improvised firearm loaded with one round live ammunition was been seized from the exclusive possession of Manu Sha @ Jabit; as on demand he failed to produce any document or license in respect of possession of such firearm & ammunition, (2) One exocet & Nylon rope about 25 feet length from the possession of Hama Sha, (3) one 'A' (8) one 14/09/2018 at 21:45 hrs from the right hand of accused Kurnam Sha, (4) one Lathi (approx 2 ft) (5) one Iron Rod and one Iron cutter locally known as 'A' (6) one small torch from their place of assembly. On asked, they failed to give any satisfactory explanation in respect of their presence at that area in the dead hours of night with such deadly weapons. So, it is crystal clear that they were assembled in that area to commit dacoity and thereby they are liable for punishment u/s 399/402 IPC & 25/27/35 Arms Act. As such, the above noted accused persons were arrested on charging all provisions of Movable Property Claret of India and issued the above articles preparing seizure list that signed by accused persons. As no public witnesses were present at the abandoned area, this seizure list was signed by the accompanied officers and 500/-

On remand to CPS, I lodged complaint against (1) Manu Sha @ Jabit (45 yrs) s/o Somanan Sha of Mukundapur, 28 Jaspur, Dist- Purulia, (2) Hama Sha (32 yrs) s/o Li Hamra Sha of dist. (3) Kurban Sha (30 yrs) s/o Kurnam Sha of dist. (4) Sh. Aman Ali (aged 25 yrs), Purulia, (5) Sh. Biru of Haldi, PS - Haldi and 3-4 unknown others for staging a case U/s 399/402 IPC & 25/27/35 Arms Act and also for arranging an investigation.
