On producing list with 13 (thirteen) arrested accused persons namely: (1) Manoj Shu @ Jabin (45 yrs) s/o Solomon Shu of Mukundapur, PS-Jaspur, Dist- Purulia, (2) Haimu Shu (32 yrs) s/o Lt. Haimu Shu of do, (3) Karban Shu (30 yrs) s/o Varnar Shu of do, with following seized articles (1) One country made improvised firearm loaded with one round live ammunition (2) One cassette & Nylon rope about 25 foot length (3) 01 Bhojoh (4) one small torch (5) One Lathi having 3/4 length (6) One Iron Rod (7) One Iron cutter (locally known as 'Aa'), that today (14/09/2018) at 21:45 hrs in course of investigation inside late (deceased) Purulia (T) PS CIDE No 776 dt (14/09/2018) I received secret information from a source that a group of criminals comprising of 9/10 heads under the leadership of Manoj Shu @ Jabin s/o Solomon Shu of Mukundapur, PS-Jaspur, Dist- Purulia, being armed with deadly weapons have gathered at the North-West corner of the bank of 'Amdaha' with a view to committing murders at the houses at Amdaha area.

Accordingly I informed the matter to O/C, Purulia (T) PS, over phone and contacted with all night patrolling officers, meeting to all I immediately along with reserve and SI Bangshi Balin Mondal, C/246, Chanchal Chakraborty, C/202, Sanjay Adhikary, K/791, Debnath Gora, NYS/290, Partha Mondal and others, left to work out the information with Cops, vehicle No WB-902-3421. At 22:55 hrs we reached at the place where the accused were assembled and preparing themselves for committing dacoity. From a distance of about 50 yards we entered there. Their whispering caused our knowledge regarding committing of dacoity at the houses at Amdaha area. We crawled nearer to them and disclose our identity and asked them to surrender, at that time, they all started to fled away, we chased them by using dogon light device. After a hot chase we could take to apprehend: (1) Manoj Shu @ Jabin (45 yrs) s/o Solomon Shu of Mukundapur, PS-Jaspur, Dist- Purulia, (2) Haimu Shu (32 yrs) s/o Lt. Haimu Shu of do, (3) Karban Shu (30 yrs) s/o Varnar Shu of do, as identified on interrogation. On further interrogation they stated that they along with (1) Sk Ajit of Udagah para, Purulia, (2) Sk Babu of Udagah para, PS- Hura and 3/4 unknown other were assembled there and preparing themselves for committing dacoity at the houses at Amdaha area. We searched the above persons and following items were recovered from their possession, i.e. (1) one country made improvised firearm loaded with one round live ammunition have been seized from the exclusive possession of Manoj Shu @ Jabin as on demand he failed to produce any document or receipt in respect of possession of such firearm & ammunition, (2) One cassette & Nylon rope about 25 foot length from the possession of Haimu Shu, (3) one Bhojoh from the right hand of accused Karban Shu (4) one Lathi approx 3/4 ft, one Iron Rod and one Iron cutter (locally known as 'Aa') & small torch from their place of assembly. On demand, they failed to give any satisfactory explanation in respect of their presence at that area in the dead hours of night with such deadly-weapons. So it is crystal clear that they were assembled in that area to commit dacoity and thereby they are liable for punishment U/S 199/402 IPC & 25/27/35 Arms Act. As such, the above noted accused persons were arrested committing all provisions of Hon'ble Supreme Court of India and seized the above articles preparing seizure list duly signed by accused persons. As no public witnesses were present at the abandoned area, this seizure list was signed by the accompanied officers and cops.

On return to PS, I lodge complaint against (1) Manoj Shu @ Jabin (45 yrs) s/o Solomon Shu of Mukundapur, PS-Jaspur, Dist- Purulia, (2) Haimu Shu (32 yrs) s/o Lt. Haimu Shu of do, (3) Karban Shu (30 yrs) s/o Varnar Shu of do, (4) Sk Ajit of Udagah para, Purulia, (5) Sk Babu of Udagah para, PS- Hura and 4/5 unknown others for starting a case U/S 199/402 IPC & 25/27/35 Arms Act and also for arranging an investigation.
