Sir.

I, SI Bhudev Ch. Kuiry of Raghunathpur PS returned to PS along with force and submitted a complaint against 30 (approx) unknown unruly supporters of BHARAT JAKAT MAIHI PARAGANA MAHAL to the effect that on 24.09.18 when I was engaged in L/O duty at Rangmati More vide Raghunathpur PS Spl. C.C. No. 30/18 dtd 24:09:18. I received the information of road blocked at Lachlmanpur More under Raghunathpur PS. Then I contacted with O/C Raghunathour and as per direction of O/C Raghunathour I went to the place. When I reached there at 09:35 hrs and found that the road at Lachbmanpur More which runs between Raghunathpur and Neturia (State Highway - 5) has been blocked by the unknown persons with bow, acrow, lathi and banner under the leadership of unknown accused. They blocked the state highway on the issue of different demands relating to initiation of OLCHIKI script in Santali languages also reservation in different jobs and thus caused harassment to the innocent people as well as threatened the people with dire consequence. The accused persons also raising slowguns in Bengali language like "AKHANI AMADER DARI MANTE HOBE NAHOLE ROAD BLOCKED CHOLTET THAKBE". I have tried to pursue the agitator to withdrawn the road blockade but they did not any attention in my words. So all the innocent public as well as the Govt, employee were detained there and subjected to enormous suffering. After a long persuasion they withdrew the blockade at 18:10 hrs.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started with proper section of law against 30 (approx) unknown accused persons and arrange for its investigation.
