Sir,


With due respect I SI Prabhodh Kr Mondal beg to state that I have been detailed for mobile duty along with force vide CC No 37/18 dttd 26.09.18 in c/w 12 hours Bangla Bandh called by BJP Party. At about 10:30 hrs received information over mobile phone that some BJP supporters try to close the Bero Boys High School. After received such information I informed the matter to O/C Raghunathpur PS and as per order of O/C Raghunathpur I along with force moved towards Bero Boys High School at about 11:10 hrs. I along with force reached at Bero Boys High School and found that about 200 unruly persons gathered in front of Bero Boys High School with deadly weapons i.e. lathi, lathi, knife, babajali etc. under the leadership of (1) Sanjit Sen @ Hudma of Bero, PS - Raghunathpur, Dist - Purulia, (2) Bapi Bauri S/o Kamikha Bauri of Vill - Puratan Bero, PS - Raghunathpur, Dist - Purulia, (3) Bandedh Bauri S/o Ghanshyam Bauri of Do, (4) Paban Khatbartya S/o Ananda Khatbartya of Do, (5) Gour Mondal S/o Dugai Mondal of Do, (6) Tapes Bauri S/o Chandu Bauri of Do, (7) Sudhamoy Chowdhury S/o Jagabandhu Chowdhury (8) Naru Bauri S/o Tarajada Buri of Vill - Larubari, PS - Raghunathpur, Dist - Purulia, (9) Manbodh Khatbartya S/o Ganapati Khatbartya of Do, (10) Chandu Bauri S/o Ram Sakti Bauri of Bandhghat, Bero, PS - Raghunathpur, Dist - Purulia, (11) Bablu Bauri S/o Gohardhan Bauri of Do, (12) Chandan Bauri S/o Swapan Bauri of Do, (13) Swapan Bauri S/o Margal Bauri of Do, (14) Pappu Barat S/o Peru Barat of Vill - Bero, PS - Raghunathpur, Dist - Purulia, (15) Santi Bistu S/o Dugai Bistu of Do, (16) Kajal Bal S/o Kajal Bal of Do, (17) Bura Rajput S/o Hunda Roy of Do, (18) Netaji Dihar S/o Prafulla Dihar of Do, (19) Potal Khatbartya S/o Huru Khatbartya of Do, (20) Nayan Chakraborty S/o Kartik Chakraborty of Natunpara, Bero, PS - Raghunathpur, Dist - Purulia, (21) Mintu Bauri S/o Sahadeb Bauri of Vill - Kuchimati, PS - Raghunathpur, Dist - Purulia, (22) Manik Bauri S/o Panchanan Bauri of Do, (23) Rabhi Chandra S/o Mahadeb Chandra of Bero, (24) Ajit Bauri S/o Nihal Bauri of Do, (25) Nirmal Roy @ Bura S/o Sarat Roy of Do and 200 villagers of Bero, Beldanga and Kharbagicha unknown accused persons. I tried to move them from in front of Bero Boys High School but unruly mobs did not pay any heed my words. As a result the teachers, students and staff of Bero Boys High School unlawfully confinement in the said school campus. So finding no other alternative I requested to O/C Raghunathpur PS for sending sufficient officer and force to maintain the law and order situation at Bero Boys High School. At about 12:15 hrs. O/C Raghunathpur PS along with force reached at the spot and seeing unruly mob he informed the situation to SDPO, Raghunathpur. After that all are tried to move the unruly mob from in front of Bero Boys High School but unruly mob threw stone, bricks towards the police personnel. As a result IC/85 Shyamsandar Mondal, IC/77 Rinto Dole, NVF/399 Samanta Murmu, NVF/120 Satyaji Kumar received injuries on their persons and the unruly mob also try to kill the police personnel with their deadly weapons, stone and bricks. Above noted unruly mob also damaged school property and 04 (four) motorcycles vide bearing No., WB 82R/6928, WB 82/0472, WB 38AA/3978 and WB 56E/0045 which were standing in front of Bero Boys High School. At about 15:45 hrs O/C Raghunathpur PS disarms the above noted unruly mob after firing 02 Pcs. Steam Shell and 01 Pc. T.R. Smoke Shell which was missed fired by C/1533 Arun Malty of Belgaon Police Line, Purulia as per order.
