I, SI Rajat Choudhary, O/C Raghunathpur PS do hereby lodge this complaint as Suo-moto against unknown miscreants for committing offence U/S 143/144/147/148/149/506 IPC, 25/27 Arms Act & 9 I.E. Act.

Today (05.09.18) when I am performed L/O duty along with force vide CC No 87/18, GDE No 178 dtd 05.09.18 from 08:15 hrs. at Raghunathpur Block - I in c/w for formation of Sabhapati and Saha-Sabhapati of the said Raghunathpur Block Office. I reached there at about 09:05 hrs.

During formation of Sabhapati and Saha-Sabhapati at the office building of Raghunathpur Block - I Office at about 11:45 hrs. a group of unlawful unknown people being armed with deadly weapons fire arms, bomb etc. attended near at Dinubabur Ghera, Raghunathpur. The said unlawful people being a procession towards Raghunathpur Block Office - I and on way they are open fire and blasting indiscriminately with a view to terror police & party supporters & tried to disrupt the formation of Panchayet Samity board at Raghunathpur BDO - I Office. On hearing the sound of bomb we all chased towards them who the persons involve in this act fled away. All the police personnel started moving into the terror points thus the vicinity got cleared. The process started & ended peacefully. No police or any other staffs any injuries. None of the miscreants could be identified.

I started this case Suo-motu against the unlawful unknown miscreants U/S 143/144/147/148/149/506 IPC, 25/27 Arms Act & 9 I.E. Act and directed SI Bhudev Ch. Kuiry for its investigation.
