Further the premises of Susil Misra Vill Guberdanga  
P.S. Raghunathpur Dist - Purulia, having Consumer No. 242110284 Meter No. ROO 38631  
was inspected by the premises. During the inspection theft of electricity was detected i.e. by passing  
the energy meter. U/S 135(1)(b) was detected. The details of passing the arrangement was damage  
installation of the incoming wire and top 2 (two) pieces of wire by which electricity directly flow to his  
house without energy registration in W.B.S.E.D.C. energy meter.
