Sir,

With due respect I SI Probodh Kr Mondal beg to state that I have been detailed for mobile duty along with force vide CC No 37/18 dtd 26.09.18 in c/w 12 hours Bangla Bandh called by BJP Party. At about 10:30 hrs received information over mobile phone that some BJP supporters try to close the Bero Boys High School. After received such information I informed the matter to O/C Raghunathpur PS and as per order of O/C Raghunathpur I along with force moved towards Bero Boys High School at about 11:10 hrs. I along with force reached at Bero Boys High School and found that some people try to close the Bero Boys High School. After persuasion teacher and student going to the class room. At that time some BJP supporters larking in the main gate and creating nuisance for this reason myself went to the gate to work out the problem. I discussed with them infront of main gate of said High School after few minutes at about 11:30 hrs 15/20 persons suddenly entered into the premises of Bero Boys High School and they discussed with the head master of the said High School about the todays present situation of the said school teachers as well as debate with the headmaster with rough languages. Suddenly I looked towards the Baranda of the said school and found one person among them namely Sk Intiaz S/o Not Known of Vill.- Jagannathdih, PS -Raghunathpur, Dist.- Purulia tried to fire with his pistol towards me but somehow the pistol was locked so he could not fired by his pistol towards me. If the fire open either I or any persons, who were larking in the main gate will be died. Then and there I along with JC/65 Shyamsundar Mondal tried to apprehend the above noted person but he fled away from the said school premises.

Therefore I pray before you that necessary legal action may kindly be taken as per law against the Sk Intiaz S/o Not Known of Vill.- Jagannathdih, PS – Raghunathpur, Dist.-Purulia.
