I, Suresh Kr. Verma, ASI of Police or Santipur Police Station, Babu-Bihuli, Bihar, India, do hereby lodge complaint to the extent that on receipt of an information or facts from regarding a chance or obstruction of West Bengal State Highway road (31-A) near Benoypur block on Santipur-Santipur road, by Block 10th N.H. Tariagan, Haldia, myself along with others namely C/1154 Jagannath Chakraborty, D/1000 Shashi Kumar Nath, C/1155 Jagannath Das, C/1157 Lalon Kanta Das, P.C./C/154 Chittap Nagta, C/1192 Sudhanshu Meena, C/1153 Ganesh Ghosh, C/1155 Sanjeev Kumar, L.H.C/1267 Tariq Hussain, constable PS C.C. No. 1171/18 U.L. 23/09/17 left the village North side Basuli PS Dhaula-Kotali. After covering the span of about 05.55 hrs, we found that State highway - 8 at Benoypur-Vardhan road blocked by some 200/250 (approx.) unauthorised people assembled will orderly occupy the State, PWD and other roads. They also over the course of time issued a notice regarding "Kataki Language" and creating fermentations and raising large scale commotion including Ambulances, Passengers buses, auto and other passengers and goods vehicles making inaudibility in public. We requested and subsequently issued several times to remove the obstruction out of the road as per rule. But they disregarded our orders at creating a police personnel also and losing no time they took dispersal way to obstruct passing away. The incident of road blockade has last till 10.30 AM. After around 06:00 PM we saw some unauthorised persons disappeared from the road. So they committed offense and punishment by C/143/ 17/140/149/186/286/287/288/289/290/291/292/293/294/295/296/297/298/299/299/300/301/302 Police Act. 1861. Having informed the PWD in D/C Santipur PS we returned at PS.

After orders at 25/09/2017 with force of 19/09 hrs I submitted a typed written complaint to C/1000 Santipur PS in such a case 0/5/142/147/148/149/150/151/152/153/154 H.P. and section 13 of West Bengal Road Act 1960 and 12. Rule 10/1961 section 200/250 (approx.) unknown persons
